**Announcement pursuant to art. 5 para. 1 lit. b) of Regulation (EU) no 596/2014 and art. 2 para. 3 of Delegated Regulation (EU) no 2016/1052**

In the period from 6 November 2023 through 12 November 2023, Bayerische Motoren Werke Aktiengesellschaft (BMW AG) acquired a total of 520,000 ordinary shares and 38,218 preferred shares.

Thereof 140,000 ordinary shares and 38,218 preference shares were acquired as part of the Share Buy-Back Programme 2023/2025. In the period from 8 November 2023 to 27 November 2023, the repurchase of ordinary shares under the Share Buy-Back Programme 2023/2025 is paused. During this period, ordinary shares will be repurchased solely on the basis of Sec. 71 para. 1 no. 2 of the Stock Corporation Act to fulfil obligations arising from an employee share programme ("Share Buy-Back Programme Employee Shares 2023"). The buyback of preference shares under the Share Buy-Back Programme 2023/2025 will continue as before.

As part of the Share Buy-Back Programme Employee Shares 2023, 380,000 ordinary shares were acquired in the period from 8 November 2023 through 12 November 2023.
