**Announcement pursuant to art. 5 para. 1 lit. b) of Regulation (EU) no 596/2014 and art. 2 para. 3 of Delegated Regulation (EU) no 2016/1052**

In the period from 27 May 2024 through 3 June 2024, Bayerische Motoren Werke Aktiengesellschaft (BMW AG) acquired a total of 216,903 ordinary shares and 73,278 preferred shares as part of its share buy-back programme 2023/2025.

The second tranche of the share buy-back programme 2023/2025 was completed on 3 June 2024. As part of this second tranche, a total of 4,075,525 ordinary shares and 975,717 preferred shares were acquired between 2 January 2024 and 3 June 2024. Together with the first tranche of the share buy-back programme, a total of 8,293,888 ordinary and 1,918,609 preferred shares were purchased.

A total purchase price (excluding ancillary costs) of EUR 499,999,329.82 was paid for the shares purchased as part of the second tranche. For the ongoing share buy-back programme (tranches 1 and 2), the total

purchase price to date (excluding ancillary costs) is therefore EUR 999,999,244.52. The average purchase price paid for the shares purchased in the current share buy-back programme between 3 July 2023 and 3 June 2024 was EUR 99.47 per ordinary share and EUR 91.21 per preferred share.
